Building Types Study: Stores and Shops In the intensely competitive atmosphere of suburban retailing, an arresting facade can bring in the business. The March study features two diverse approaches designed to attract customers. One solution features a sophisticated use of high-style building materials. The other approach is radical—designed by architect-sculptors to shock and spook. The former approach is exemplified by Burdine's Department Store in Tampa, Florida, whose architect was Walter Stanton. The latter is embodied in the work of SITE, Inc. for Best Products Company, whose executives perceived that SITE, Inc.'s radically different facades would communicate effectively in the jungles of shopping centers. They did, and sales have jumped by as much as 50 per cent.
