HOUSES WITHOUT PRIORITIES

The place of the custom-designed house in the defense program . . . what priority regulations and material shortages mean to non-defense house construction: an analysis of the strategic materials normally consumed by this class of building, the considerable reduction that is possible, and the desirability of a system of allocation designed to make available items (like nails and wire) that are absolutely essential if construction of above-\$6,000 houses is not to be stopped entirely. How this can contribute to defense and provide useful employment for the 6 or 7 thousand architects who are largely dependent on residential work.
