Major fields of research

The research carried out over the last decades is focused around the following areas.

- (i) The labour market segmentation approach:
 - towards the development of a theoretical framework for the analysis of the functioning of the labour market;
 - a methodological approach for the analysis of the internal labour makets (how firms behave in terms of screening, hiring, training, upgrading and firing)
 - empirical analysis of the internal labour markets.
- (ii) The institutional framework of the labour market (labour market policies, industrial relations, internal labour markets):
 - an analysis of the evolution of the industrial relations system and its impact on the functioning of the labour market;
 - homework in developed countries (characteristics of the workers involved, extension of the phenomenon, its dynamics in the long run, the policies);
 - non-standard forms of work in Italy: characteristics, diffusion, weight, and economic role.
- (iii) The industrial structure and the role of small firms:
 - small firms and industrial districts: analysis of the reasons for the survival (and the success) of small firms in Italy;
 - comparative analysis of the functioning of the labour market in traditional industrial sectors: the construction industry in Italy; the footwear industry in the North, in the Centre and in the South of Italy; the tourist industry in Spain, France and Austria.
- (iv) Fertility, labour force participation and unemployment:

- a comparative analysis across countries of the relationship between fertility and female employment;
- the fertility puzzle in Italy: the relationship between the family formation process, the welfare state and the labour market.

(vi) Gender and employment:

- a gender analysis of the evolution of the labour market;
- the structure of earnings (and the gender pay gap);
